***All MIBRS and Use of Force classes offered below, which are presented by MSHP CJIS personnel, are for Law Enforcement and Criminal Justice Agencies only. ***

MIBRS Training – This course is designed to train those who will be classifying and scoring offenses for MIBRS. The course will cover offense definitions, what offenses are reported, what information is needed, accounting for stolen, recovered, seized, and damaged property, preparing and submitting the MIBRS Submission files, and Missouri unique MIBRS requirements. The course will cover common warnings and errors and how to correct them, CAT audit tool, and Crime Insight reports. This course is not mandatory but is recommended for any personnel involved in the taking, receiving, writing, and/or reviewing an agency's offense report and those responsible for the MIBRS file submission.

Attendees will receive 6 POST continuing education credits – four-hour technical studies and two-hour legal studies.

Use of Force Training – This course is designed to train individuals who will be reviewing and submitting UoF data on the Show Me Crime website via Crime Insight. The course will cover what data is collected for a UoF incident, develop an understanding of the three elements that constitute a UoF incident, and who should register to submit data for your agency. It is recommended that any personnel designated by the agency head to review an agency's UoF incident reports and/or personnel responsible for UoF submissions attend this course.

Attendees will receive 2 POST continuing education credits – one-hour technical studies and one-hour legal studies.

COST: There is no cost for these training courses.
