****REMINDER****

***All MIBRS, Use of Force, N-Dex, and Livescan classes offered below, which are presented by MSHP CJIS personnel, are for Law Enforcement and Criminal Justice Agencies only. ***

MIBRS Training – This course is designed to train those who will be classifying and scoring offenses for MIBRS. The course will cover offense definitions, what offenses are reported, what information is needed, accounting for stolen, recovered, seized, and damaged property, preparing and submitting the MIBRS Submission files, and Missouri unique MIBRS requirements. The course will cover common warnings and errors and how to correct them, CAT audit tool, and Crime Insight reports. This course is not mandatory but is recommended for any personnel involved in the taking, receiving, writing, and/or reviewing an agency's offense report and those responsible for the MIBRS file submission. Attendees will receive 6 POST continuing education credits – four-hour technical studies and two-hour legal studies.

Use of Force Data Collection – This course is designed to train individuals who will be reviewing and submitting UoF data on the Show Me Crime website via Crime Insight. The course will cover what data is collected for a UoF incident, develop an understanding of the three elements that constitute a UoF incident, and who should register to submit data for your agency. It is recommended that any personnel designated by the agency head to review an agency's UoF incident reports and/or personnel responsible for UoF submissions attend this course. Attendees will receive 2 POST continuing education credits – one-hour technical studies and one-hour legal studies.

N-DEx Training – This course provides students with an overview of the Information Sharing system (National Data Exchange) available in Missouri. This system provides criminal justice agencies with the ability to share and retrieve information to quickly and securely find leads, solve and prevent crimes, and promote public safety. Within this course, attendees will be made aware of the National Data Sharing Policy to include an overview of the Criminal Justice Information Services Security Policy, Dissemination information, as well as an overview of the analytical tools available within each database. Basic searches and/or complex searches will be performed via demonstration during this training. This system is available to all Criminal Justice entities within the state that have a secure state level connection. It could be particularly useful for Dispatchers, Detectives, Officers, and Clerical Staff. Attendees will receive 2 POST continuing education credits – one-hour technical studies and one-hour legal studies.

Livescan Basic Training - This course trains new users on the requirements and processes of collecting fingerprints via the Livescan machine. The course will cover how fingerprints are used to create a criminal history and what identifiers need to be captured. Any personnel designated by the agency to collect and process fingerprint submissions should attend this course or one taught by their agency instructor. Attendees will receive 3 POST continuing education credits – one-hour technical studies, one-hour skill and one-hour legal studies.

Livescan Instructor/Admin Training - This course is designed to train Livescan Instructor/Admin for each agency. All attendees must have previously attended the Livescan Basic (or equivalent) taught by MSHP or qualified agency trainers. This course will cover administrative functions, user tracking, and instructor materials for teaching Livescan Basic. Upon completion, students will be certified to teach the Livescan Basic course at their agency and perform administrative functions to ensure compliance with Livescan policies. Any personnel designated by the agency to collect and process fingerprint submissions should attend this course if they wish to train users at their agency. Attendees will receive 2 POST continuing education credits – one-hour technical studies and one-hour legal studies.

COST: There is no cost for these training courses.
